Bert is a member of the Council on Foreign Relations and has been a contributor to the Op/Ed pages of the Los Angeles Times. He is a recipient of the Interest of Justice Award by the Legal Aid Foundation and Entertainment Attorney of the Year by the IAOTP. He teaches the course on entertainment law at Stanford Law School, lectures

annually at Harvard Law School and has lectured on Shakespeare at various venues, including the Smithsonian Institute in Washington D.C.
