Representative Experience

- Prevailed on behalf of partner in real estate dispute regarding Los Angeles based apartment complex, defeating motions to dismiss and for summary judgment brought by the opposing party. Successfully enforced disputed settlement agreement, resulting in recovery of attorneys' fees and costs and sale of property.
- Obtained summary judgment on behalf of defendant in multi-million dollar dispute regarding alleged contamination of industrial property.
- Obtained summary judgment on behalf of commercial real estate brokerage, securing the dismissal of a civil lawsuit brought by the Los Angeles City Attorney's Office against the brokerage related to a commercial cannabis real property lease. The ruling came nearly two years after the City Attorney's Office originally filed suit and cleared the brokerage and its agents of any wrongdoing.

The arbitrator dismissed the Claimants' suit in its entirety, and Respondents were awarded full recovery of attorneys' fees and costs.
- Obtained summary adjudication on behalf of individual plaintiff seeking to recover real and personal property which was unlawfully transferred to various parties. Obtained quiet title judgment to two separate parcels of real estate.
- Obtained quiet title judgment from the Los Angeles Superior Court in connection with the sale of
 commercial real property. Clients were informed that multiple deceased parties were "on title" for the real
 property. Successfully petitioned the court for an order adjudicating that the clients were the sole owners
 of the property, thus allowing the sale to go through.
